Convene

Presiding Commissioner Steve Daleske called the meeting of the Benton County Commission to order at 9:00 a.m. on June 6, 2022 at the Board Room. Attendance: Larry Berry, Present: Scott Harms, Present: Steve Daleske, Present.

Approval of Prior Minutes

District 2 Commissioner Scott Harms made the motion to approve prior minutes dated 5/31/2022. District 1 Commissioner Larry Berry seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes).

Fuel Bids

District 1 Commissioner Larry Berry made the motion to approve the bid from Zollicker Oil Company for unleaded gasoline for Road District #1 at a cost of \$3.925 per gallon. District 2 Commissioner Scott Harms seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes). Other bids were received from Warsaw Oil Company at a cost of \$4.12 per gallon, and from MFA Oil Company at a cost of \$3.975 per gallon. The County accepted the low bid price.

District 1 Commissioner Larry Berry made the motion to approve the bid from Zollicker Oil Company for diesel fuel for Road District #1 at a cost of \$4.325 per gallon. District 2 Commissioner Scott Harms seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes). Other bids were received from Warsaw Oil Company at a cost of \$4.70 per gallon, and from MFA Oil Company at a cost of \$4.765 per gallon. The County accepted the low bid price.

Poor Boy Road

Commissioners noted conditions of Poor Boy Road; maintenance of this road will commence as soon as weather permits.

Road Vacation - Sportsman's Paradise 5th Addition

Attorney James Kjar met with Commissioners pertaining to the road vacation of The 25' alleyway between Lot 5, Block 5, and Lot 8, Block 1, of Sportsman's Paradise Fifth Addition Subdivision. This matter was originally heard on May 2, 2022, and was postponed until today for further discussion of this matter. District 2 Commissioner Scott Harms made the motion to approve the road vacation as presented, District 1 Commissioner Larry Berry seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes).

Treasurer and County Clerk Reports

The Treasurer presented his weekly financial report; the County Clerk submitted bills for approval and payment.

Bid Opening - Election Equipment

The bid opening was held for new election equipment for the County Clerk's Office. One bid was received for this equipment, from Henry M. Adkins and Son, Inc., in the amount of \$61,811.00, which includes trade-in and recycling costs for old equipment. District 2 Commissioner Scott Harms made the motion to purchase this equipment utilizing American Rescue Plan Act funds. District 1 Commissioner Larry Berry seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes).

Twin Hills Drive

A telephone conference call was conducted with Gary Smith to discuss road conditions on Twin Hills Drive; maintenance will be conducted as weather allows.
