This new equipment permitted Benton County to complete the mandatory transition to an all-digital system as required by the Federal Communications Commission (FCC). With this change, the Benton County Sheriff's Office frequency is encrypted, and transmissions will no longer be available on a scanner. This change will protect law enforcement officers and the general public by preventing sensitive information from being transmitted on a live, scannable frequency. When this upgrade is completed, communications will improve in the areas where radio frequency reception has been a long-term problem.
