The Benton County Missouri Sheriff's Department is inviting proposals from qualified firms to provide the following items:

- a) One (1) exacqVision A-Series desktop server. Item IP04-04T-DT
- b) Professional software updated to the current version
- c) Server license transferred to new MAC address
- d) NETGEAR ProSAFE 24-Port Gigabit PoE+ Smart Managed Switch 384w (GS728TPP)
- e) Setup and transfer cameras to new NVR (15 cameras)
- f) Install and configure new switch
- g) Three (3) Cat 5e Network Wires and Modules installed from (2) Clerks Office to Prosecutor's Record's Room, (1) From Accessor/Personal Property Camera to Clerk's Office switch rack.

Any proposal received after designated date and time shall not be considered. Proposals will not be opened publically.

Benton County reserves the right to reject any and all proposals, in part or in whole, and to select the most responsive and responsible firm(s) as deemed in the best interest of the County. All submitted proposals will become County property.

Proposals shall be as thorough and detailed as possible so that Benton County may properly evaluate Respondent's capabilities to provide the required goods. County may request Respondent to supplement initial proposals.

Proposal shall include the following:

1. The name, title, address, and phone number of the individual with the authority to discuss all contents of the proposal;
2. Complete quote of **ALL** specifications listed.

The proposal may also include any additional information that the Respondent believes will add to the persuasiveness of the proposal.

County shall not be responsible for Respondent's costs or expenses in responding to this RFP.
