1. General

The Benton County Missouri Sheriff's Department is inviting proposals from qualified firms to provide fifteen (15) X10DR Secure Wireless Microphones (Radio Accessories).

2. Proposal Submittal

Proposals must include the Respondent's name and address. Proposal must be submitted prior to 12:00 PM, local time on or before Thursday, September 10th 2015. Proposals will not be accepted after the date and time designated above. It is the sole responsibility of the Respondent to see that their proposal is delivered and received in proper time. Any proposal received after designated date and time shall not be considered. Proposals will not be opened publically.

Benton County reserves the right to reject any and all proposals, in part or in whole, and to select the most responsive and responsible firm(s) as deemed in the best interest of the County. All submitted proposals will become County property. Winning bidder will be notified sometime during the week of September 13th, 2015.

3. Proposal Format

Proposals shall be as thorough and detailed as possible so that Benton County may properly evaluate Respondent's capabilities to provide the required goods. County may request Respondent to supplement initial proposals.

Proposal shall include the following:

1. The name, address, and phone number of the respondent with the authority to discuss all contents of the proposal;
2. Complete quote of **ALL** specifications listed.

The proposal may also include any additional information that the Respondent believes will add to the persuasiveness of the proposal.

County shall not be responsible for Respondent's costs or expenses in responding to this RFP.

5. Vendor Requirements

- Vendor must have at least 1 full-time, qualified service technician on staff during all business hours.
- Vendor must have at least 1 mobile installation technician on staff during all business hours.
- Vendor must be located within 2 hours of the Benton County Sheriff Department home office.

15 Wireless Microphones to directly interface with our existing radios, must be X10DR microphones per attached documentation.

The county has tested the specific microphone and required and EXACT match in all proposals. Anything outside of the exact specifications will not be considered.
