Mr. Blankenship stated that if reimbursement was available, the City of Warsaw could utilize their burn site to dispose of material from the government agencies and private individuals. This burn site would be open daily from 7 a.m. until 7 p.m. for the period of May 20 through June 6, 2025.

Attendees agreed that a local state of emergency existed. Director Mayfield prepared an emergency declaration proclamation and/or resolution. District 2 Commissioner Scott Harms made the motion to approve the proclamation as presented, District 1 Commissioner Larry Berry seconded the motion.
